- **b.** *Confirmed:* The RoSPA report has been received. Several lower risk issues were raised including;
 - i. A budget was set to have the trip hazard at the gate resolved. Robert Kemp will be asked to quote.
 - ii. Zip wire whilst the inspection found nothing wrong, it was recommended that the zip wire is dismantled completely to check for wear. A quote will be obtained.
 - iii. Rocker Seasaw a small split has been found on the underside of the handle. A quote will be obtained for repair.
 - iv. Strimmer damage has been reported on the trim trail. The grass cutting team will be asked to take more care.
- **28. Street Lighting and Parish Council Assets;** Street lights are still not going off at midnight every night. The Clerk has reported this several times to E.on and received no response, but will try again. There is a light not working on Green End, Cllr Watson will provide the details so that the Clerk can request repair.
