83. Buckinghamshire Council: Highways, Footpaths & Footways

- **a.** Vegetation growing on the verges by the bridge between Winslow and Granborough obscures the view making it difficult to see oncoming vehicles. This has been reported via Fixmystreet, ref: 40169915.
- **b.** To receive any updates on outstanding issues;
 - i. Cracked Pavement Ref 40166132. The repair is complete.
 - ii. Overgrown Hedges and Street Light in Sovereign Close were reported to Street Scene on 23rd June. The Local Area Technician asked Street Scene to resolve the issue on 30th June. It is noted that it may have to wait until nesting bird season is over.
 - iii. The Dog Waste Bin has now been moved.
- **c.** *Confirmed;* A formal complaint raised across various departments of Buckinghamshire Council was sent to the complaints team on 7th July.

84. Play Area;

- **a.** Inspection Reports indicate no further action is required at this time, but it is noted that the Litter Bin is proving difficult to unlock.
- b. Resolved; To accept the recommendations in Cllr de Niese's report following the RoSPA Inspection. The Clerk will ask Roy Randles to meet with Cllr de Niese to discuss work required with a view to completing it after the summer holidays. The Clerk will also source a safety sign for the play area gate.
 RTM will be asked to cease strimming around the base of wooden posts and instead to apply a weedkiller twice a year.
- **c.** *Confirmed;* The zipwire has been re-tensioned, with thanks to Chris Wattam. The Clerk will ask Oving Parish Council if they have a solution for zipwire disassembly.

 - iv. Overgrowth of the pavement in Church Lane; a formal letter was sent to Merlin Powell on 24th June, no response has been received. A further letter will be sent before referring to Buckinghamshire Council's legal department.
- **c.** Painting of the White Gates at either end of the village is complete.

RTM have quoted £160 + VAT to cut back the overgrown vegetation along the alleyway opposite The Crown. **Resolved**; To accept this quote.

Cllr Oakland met with RTM regarding a decline in quality of the last village cut. The situation will be monitored.
