- 197. Open Forum for Parishioners; No items were raised by members of the public.

- 199. Minutes;

Resolved: To accept the Minutes from the 18th January 2022 as a true record.

200. Finance;

- a. *Resolved:* To accept the accounts for January and February 2022.
- b. Ratified: Payments 86 to 95 inclusive were ratified, please see Appendix A.
- c. Confirmed; The precept request has been accepted, instalments dates are 15/4 and 16/9.
- **d.** *Resolved;* To open applications for the small grants scheme. Applications to be considered on 5th April, recipients must give a short presentation at the Annual Village meeting on 24th May, after which grant payments will be made. The application form will be available from the website and the scheme will be advertised on the Granborough and North Marston Community Facebook Page.

201. Planning:

- **a.** *Resolved;* To agree a response of no objection to application 22/00651/APP at 15 Marston Road for rear extensions and windows.
- **b.** *Confirmed;* A status update on current planning applications was obtained from the planning portal, please see Appendix B.
- **202. Buckinghamshire Council Updates;** Cllr Chilver's update included that next year's Budget is approved, that distribution of funding for the Community Boards is to be decided and that Council Offices are flying the Ukrainian flag. Cllr Chilver was asked to speak to our LAT regarding the blocked drain on Green End (ref: 2255203) and to find out if a formal notification will be made regarding the abandonment of the OxCamb Project. Cllr Chilver explained that the VALP should afford protection against speculative building.

204. Buckinghamshire Council: Highways, Footpaths & Footways

a. The following new issues have been raised;

- i. Trees cleared from the road after storm Eunice are blocking the ditches on the Granborough side of the bridge on Winslow Road causing flooding. The Clerk will report the issue on Fixmystreet, Cllr Chilver will raise it with our LAT, Matt Whincup.
- **b.** The pothole on Green End has been repaired. There is no progress on ref: 2255203 (the blocked drain on Green End), Cllr Chilver will follow this up with our LAT. There is no progress on ROW refs 210972197 or 210933015

205. Play Area;

- **a.** Cllr Smedley will look into replacing a grip on the rocking horse handle. Inspection Reports indicate no further action is required at this time.
- **b.** Current Rotten fence posts have been replaced; the situation will be ongoing.

206. Glebe Land Project;

a. The Working party has recently burned previous rubbish, clearing areas of the site. The lease is undergoing minor alterations. Due to offsetting legal and fencing costs against rent, the first rent payable will be on 1st October 2025, the lease will become renewable in 2033. We are aware that neither lease will automatically renew. Work on creating ponds is due to start soon. Before and after photos will be required.

b. *Resolved:*

The Council authorise Mrs V Firth (Clerk/Proper Officer) to be the duly authorised person to swear a statutory declaration confirming that the Tenant, Granborough Parish Council, is aware that, at the end of the lease, it will not have an automatic right to a new lease or any right to stay in the property.

The Council authorise Cllr Philip Oakland (Chairman) and Cllr Hugh Ellerton (Glebe Project) to sign the lease on behalf of the Parish Council. The Council agreed to formally minute the signing of the lease at the Council Meeting following the date of signing. Cllr Ellerton will collect grant monies, submit a grass cutting invoice, and the bench and wildflower seeds will be obtained. The Clerk will investigate safety responsibilities for ponds.

207. Street Lighting and Parish Council Assets

- **a.** Street Light No 2. on Church Lane has been repaired.
- **b.** Since the electricity markets are closed, finding a competitively priced supplier for Street Lighting has been deferred.
- **c.** Npower Business were contacted on 21st February and chased on 3rd March, no response has been received. No bills have been issued for January or February and we await a schedule of payments since rates have been weighted for winter, with no detail available.

- a. The Parish Council has set aside £500 to support the activities being arranged by the Charter Fayre committee. The road closure application for a Street Party being progressed by Dean Bunyan, there is a fallback position if the street closure is not agreed.
- **b.** Resolved: To set aside a budget of £250 to plant a tree and buy a plaque from the Royal British Legion for the Queens Green Canopy. Cllr Smedley will investigate the details.
