- **54. Buckinghamshire Council Updates;** Cllr Chilver explained there are currently long delays on phone lines to Bucks Council due to bin collection issues in the south of the county.

#### 56. Buckinghamshire Council: Highways, Footpaths & Footways

- **a.** The following new issues have been raised;
  - i. Visibility of oncoming vehicles approaching the bridge between Granborough and Winslow, is completely obscured. Cllr Chilver will raise this at his meeting with the Local Area Technician on 7<sup>th</sup> July.
  - ii. Cllr Watson photographed a rotten bridge on the footpath behind Green End. The clerk will report the issue.

#### 57. Play Area;

- **a.** New issues; The Clerk will investigate flexible spikes to mount on the cross bar at the top of the Toddler Swing to prevent birds from landing. Inspection reports indicate that no other action is required at this time.
- **b.** The RoSPA report was deferred until Cllr de Niese returns.

#### 58. Glebe Land Project;

- a. Ratified; it was agreed to pay an invoice for grass cutting, which has already taken place.
- **b.** The fencing will be replaced imminently, hopefully before the next meeting. The three benches are in place on concrete plinths. Neither pond is likely to hold water so liners will be required, and Cllr Ellerton will look for a grant towards costs. The wildflowers haven't taken yet but bind weed is a problem and Cllr Ellerton will seek advice on its removal.

#### 59. Street Lighting and Parish Council Assets

- a. Street Light No.10 on Marston Road was reported to E.on on 1st June 2022
- **b.** Swarco have serviced the MVAS Unit, no issues were found
- **c.** Street Light No. 4 on Church Lane is now obscured by the tree. The Clerk will ask RTM for a quote for revealing the light.
- **60. Devolved Services;** RTM returned to cut the area of grass missed after the last village cut. Weed Killing has taken place but has not been charged for.

#### 61. Neighbourhood Plan;

**Resolved;** To accept the Examiners report and ask Buckinghamshire Council to proceed with the referendum. The Neighbourhood Plan and settlement boundary must be amended in accordance with the Examiners response, which is delegated to the Steering Committee, in consultation with the Chairman and/or Vice Chairman of the Parish Council where necessary.
