114. Buckinghamshire Council Updates; No updates were received

Resolved:

116. Buckinghamshire Council: Highways, Footpaths & Footways

- The following new issues have been raised;
 Residents are putting obstacles on the Highways owned verge on Green End, to discourage vehicles using verges for passing. These obstacles are hazardous for vehicles, cyclists, and horse riders. *Resolved:* Cllr de Niese will note the new obstacles for reporting to Highways.
- **b.** Updates on outstanding issues;
 - i. RoW Ref: 220795649 damage to a footpath bridge no progress
 - ii. RoW Ref: 220647011 rotten footpath bridge no progress
 - iii. Ref: 2255203 Green End Drain reported to TfB on 20/8/20

 **Resolved:* Cllr Chilver will chase this up again with our Local Area Technician.

117. Play Area;

- a. New issues raised;
 - i. The two junior swing seats need replacing. *Resolved;* The Clerk will source prices, to be fitted as part of the ongoing works.
- **b.** Updates on existing issues;
 - i. Cllr de Niese is meeting with Roy Randles at the play area on 21st October to discuss the actions arising from his report. The council agreed a budget for this work.
 - ii. The Seesaw Handle will also be discussed with Roy since Cllr Ellerton's contact was unable to undertake welding without an electricity supply.

118. Glebe Land Project;

- **a.** Progress report; A meeting of the Community Boards environmental action group took place at the Glebe on Saturday 15th October.
- **b.** Actions required;
 - i. Volunteer work over the winter months to clear brambles, vines and suckers.

- ii. A liner for the bottom pond may be required, estimated at about £600
- iii. A noticeboard will be required, cost to be established
- iv. Signage is required including "please take your litter home" and "keep dogs out of the pond", requirements and costs to be established
- v. Flower seeds will be required, cost to be established.

Resolved: Cllr Ellerton will produce costings and timescales for the next meeting. Cllr Ellerton will also provide a general update for the website.

- **c.** Update on outstanding issues;
 - i. The entrance work is complete, awaiting invoice
 - ii. A grant funding application for £900 for the upper pond has been submitted
 - iii. Queens Green Canopy; 500 trees are being supplied, for planting along the north side of the public footpath accessed opposite The Crown, rising to a pond in the corner of the field, where a woodland will be established. A grant request for 400 tree guards has been made, Bruce Clarke has volunteered to pay for the stakes. The National Trust are loaning planting tools.

Resolved; Cllr de Niese will add a request for volunteers to Facebook.

The Clerk will add a request for volunteers on the website.

119. Street Lighting and Parish Council Assets

- a. New issues requiring attention; The pavement from the village hall down to the Crown is collapsing. *Resolved:* Cllr Oakland will send photos to the Clerk, who will report the matter on Fixmystreet. Cllr Chilver stated that a village walkaround could be arranged with our LAT.
- **b.** Updates on outstanding issues
 - i. Bench by the bus stop; work is complete.
 - ii. Defibrillator; Welmedical have cancelled the booking. *Resolved:* Cllr Oakland will book a new collection appointment.
 - iii. Light No. 5 on Green End has been repaired, all streetlights are believed to be in working order.

- **a.** Village Hall Booking System, the Trustees are going to source a booking system.
- **b.** *Resolved;* the Council approved purchase of a dongle to provide internet access.
