- 131. Open Forum for Parishioners; No items were raised by members of the public.

### 134. BESS Proposal

- Given the unpredictable validation timeframe for the application, the following is planned but subject to change; The questionnaires (which are complete except for an application reference number), will be distributed by the working party prior to an open meeting for residents, to be held on 6<sup>th</sup> January. The working party will use feedback from the questionnaires, to present the parish council with the village opinions, at a meeting on 16<sup>th</sup> January. The parish council will then agree a general response to the application, an in-depth written response will follow.
- **b.** The application has been submitted via a third party portal and has yet to reach Buckinghamshire Council. Once received a validation process of indeterminate length will take place. The parish council will receive consultee notification, from which point the parish council has 35 days to respond.

  - ii. Resurfacing work outside the church is still outstanding,
  - iii. The road closure signs have now been removed.

#### 139. Play Area;

**a.** The lower gate has no tension in the spring

**Resolved:** Cllr Smedley will try to remedy this when the weather is dry, Inspection Reports indicate that no further action is currently required,

ii. Soldier Silhouettes; *Resolved:* after discussion highlighted a lack of suitable sites, it was agreed not to purchase silhouettes currently.

### **b.** Updates on outstanding issues

- i. The closed noticeboard will be ordered tomorrow,
- ii. Resident complaint; the anonymous complainant has not responded to an invitation to meet with Cllr Oakland to discuss their complaint.
  Cllr Oakland confirmed the MVAS is working. Highways have previously advised that there are limited suitable and safe sites for speed indicator devices in Granborough due to the length of straight approach required, to detect speed. There are three approved ground screws currently, which the device can be moved between. *Resolved:* the clerk will investigate the costs and procedures involved in upgrading the MVAS sign to a newer solar version. The parish council decided against pursuing any kind of traffic calming measure.

NOTE: Speeding is dangerous and illegal. No residents should speed at the MVAS sign to "test" whether it is working, the sign only illuminates when approached at speeds above the speed limit.
